Only hand-made items (made by the Exhibitor in the USA) will be allowed in the Arts &
Crafts Area. Exhibitors selling books, notions, pictures or prints (unless originals done by
Exhibitor), T-shirts, etc. should apply for booth in the Marketplace.

APPLICATION DEADLINE:

Applications and payment must be received by June 15, 2010.

Applications received after June 15, 2010 will require an additional \$50.00 fee
(\$100 additional fee for Food Court)

No applications will be accepted after June 25, 2010.

REFUNDS:

Requests for refunds must be in written form ONLY. All requests received by mail prior
to July 1, 2010, will be reimbursed 50% of all fees paid.

RESERVATIONS:

The Campbellsville Fourth of July Committee reserve the right to reject any exhibitor they feel is inappropriate for that area. Any such exhibitor will be required to leave and no refund will be given.

NO ITEMS CAN BE SOLD WITH THE CAMPBELLSVILLE FOURTH OF JULY NAME OR LOGO.

SET-UP:

Exhibitors in downtown Campbellsville will be allowed to setup Friday, July 2nd after 3:00 pm. Exhibitors wanting to setup at Miller Park will be allowed access only after 12 noon on July 3rd. You must check-in with the chairpersons before entering the booths/food court area. All vendors in downtown Campbellsville must be set-up and ready to sell by 5:00 p.m. on July 2nd.

No Setup will be allowed after 5 p.m. July 2nd or after 8 a.m. July 3rd

BREAKDOWN:

All Exhibitors in downtown Campbellsville must not break down until after 4 p.m. July 3rd. All exhibitors at Miller Park must not breakdown until after the Fireworks Show July 3rd.

PARKING:

PLEASE OBSERVE "NO PARKING" SIGNS ON PUBLIC THOROUGHFARES.
VIOLATORS WILL BE TOWED.

RESTRICTIONS:

NO ANIMALS (PETS OR OTHERWISE) WILL BE PERMITTED!

In agreement with the Humane Society and the Taylor County Animal Shelter, the Taylor County Animal Shelter will be the only organization allowed to display animals. Any exceptions must be granted IN WRITING by the 4th Board prior to arrival for set-up.
